

## Terms & Conditions

1. This Special Offer is only available to **HKCS Members / Student Members / Staff** as learners (“**Learners**”).
2. The Special Offer for HKCS (“The Special Offer”) includes Cloud Computing, Cyber Security, Big Data & Business Analytics, and Data Science, and related Post-graduate Programmes (**PG Programmes**) of MIT and Caltech online courses as per “Courses List”.
3. The Special Offer are as follows:
  - (i) **Discount: 15% off; for PG Programmes: 5% off** until further notice;
  - (ii) Upon **minimum NET purchase (AFTER discount) of HKD5,000**, **one-off HKD1,000 Cash Coupon** can also be used (**expiry: 31 March 2024**)
  - (iii) For **NEXT** purchase, **HKD500 Cash Coupon (expiry: 6 months from previous purchase)** can be used, upon **minimum NET purchase (AFTER discount) of HKD5,000**. This offer is valid until further notice. (**Pls quote in email: previous purchase date, & previous payment reference**)

For clarity, 15% off Discount and HKD1,000 (or HKD500, where applicable) Cash Coupon **can be used at the same time**. But **maximum only one Discount and one Cash Coupon** can be used concurrently.

Original Fee:	<b>HKD10,842</b>
After Discount (15% off):	<b>HKD9,216</b> (Since over HKD5,000, so <b>qualified</b> for HKD1,000 Cash Coupon)
(Deduct	HKD1,000 Cash Coupon)

<b>Net Fees Payable</b>	<b>HKD8,216 (=24% off Original Fee)</b>

4. Depending on the course, the fee may include one or more of below:
  - (i) Pre-recorded online training videos (“**Self-paced Learning**”) &/or
  - (ii) Public classes of live instructor-led virtual classes (“**LVCs**”), if relevant, &/or
  - (iii) If explicitly stated, **Virtual Lab**, which refers to relevant software licence or environment. In general, this may be embedded in LMS (Learning Management System), or free download is understood to be generally available to Learners directly from the relevant software provider.

**Kind Reminder: For courses with LVCs included, usually at least one batch of LVCs is available. Upon activation of LMS login account, Learners have to register on their own for the preferred LVC batch in LMS. Pls. refer to LMS User Guide.**

5. Unless explicitly stated, course fees exclude professional exam vouchers, exam kits, other trainings, consulting services, private classes of LVCs etc.
6. Only after receipt of ALL of below by PTI, order processing would start. Pls allow 2-3 weeks for processing.
  - (i) Payment **and**
  - (ii) Completed Order Form, **and**
  - (iii) A copy of payment record.

### **Kind Reminder- Order Form**

- *Pls note email address, once provided by Learner, **can NOT be changed**. Our activation email from Simplilearn will also be sent to such email address. Learner would also need to use such email address to register LMS a/c.*
  - *In case of incomplete Order Form, &/or any required info is missing, the Order Form is **deemed to be incomplete, and processing can not start, unless & until all required info is provided. To avoid unnecessary delay in processing, Learners are reminded to provide all required info in Order Form***
7. Validity Period of Online Courses:
    - (i) One year access **from date of activation email sent** by PTI &/or Simplilearn, **irrespective of** when Learner activates login account of LMS, including but not limited to delay in activation.
    - (ii) Exact activation date **should NOT be later than one month after receipt of activation email, and after which, access to the online courses would expire and lapse**, and amount paid will **not** be refunded.
  8. If **more than one month** after emailing us the Order Form and payment record, Learner still has not received activation email,
    - (i) Learner would have sole responsibility to inform PTI **within 5 working days by email**, with acknowledgement by PTI.
    - (ii) If no acknowledgement email is received, Learner has sole obligation to inform PTI **within 5 working days and to follow up**.
  9. Re Point 8 above, if no notification email re non-receipt of activation email **OR** re non-receipt of acknowledgement email is sent by Learner, **AND** if no follow up by Learner, the course(s) is/are deemed to have been activated already.
  10. After payment, pausing &/or putting on hold availability of the online course is **not** possible.
  11. Each course can only be used once only. Any order placed &/or amount paid, cannot be revoked, and is non-cancellable, and not refundable. The course can not be transferred or assigned, re-used, exchanged, or registered for another course or learner or another email address.
  12. Notice or email sent by Learner or PTI is deemed to be sent at the time it is sent.
  13. Without any notice, the course brochures &/or course info &/or courses contents &/or components of Course (such as consisting of SPL &/or LVCs) is/are subject to changes from time to time, and the courses are also subject to removal, &/or cancellation & become unavailable, at PTI &/or Simplilearn's sole discretion.
