**Hong Kong Computer Society CIO Board Survey Results Released**  
*CPIT Credentials is recognized as the key in fostering the development of the IT industry*

**18 September 2014-Hong Kong** - Information technology is a key element leading to better business and organizational development, thus enhancing the need for IT professionals to pursue self-excellence in order to stay competitive in the field. Certified Professional of IT (CPIT) Credentials is one of the professional certifications in IT industry, providing employers with a reference to assist them during recruitment processes while encouraging IT professionals to pursue self-improvement.

CPIT is a certification system that assesses and certifies IT professionals based on knowledge, skills, ability and proven work experience. There are now 8 titles in the certification:

**Examination-Based training programs** are now available in various vocational training institutions, including Institute of Professional Education and Knowledge (PEAK) of Vocational Training Council and Productivity Training Institute (PTI) of Hong Kong Productivity Council.

CPIT Credentials has already been established for 7 years. Hong Kong Computer Society conducted a survey in January 2014 among its Chief Information Officer Board (CIOB) to examine the effectiveness and significance of the certification. According to the results, only a small amount of companies consider CPIT Credentials as a weighting factor when making employment decisions. However, many companies plan to take it into account in the future (please refer to the table below for details). It is obvious that there has been a rise in recognition for CPIT Credentials

among both employers and employees in IT industry.

Survey results:

Distinguished IT professionals have already expressed their supportive attitude to CPIT Credentials, perceiving it as both beneficial to employers and employees.

Mrs. Agnes Mak, MH, JP, Executive Director, Hong Kong Productivity Council, pointed out, "CPIT helps employers to screen candidates and select those with professional competence to meet the industry's standards. On the other hand, employees can make use of CPIT to ascertain their skills, knowledge and experience at a certain level, so that they have a better chance of getting employed".

Ms. Susanna Shen, Head of Corporate Information Technology, The Hong Kong and China Gas Company Limited, suggested that, "CPIT allows employers to identify candidates' competence. At the same time, IT professionals can ascertain their own capabilities and qualifications through CPIT".

Mr. Andy Bien, Chief Information Officer, Airport Authority Hong Kong, deliberated that, "CPIT provides a pathway for continuous learning which will eventually improve the overall quality of the industry".

Finally, Ir. Sunny Lee, JP, Office of Vice-President (Administration), City University of Hong Kong, also viewed, "CPIT can provide a more objective and professional assessment to evaluate the competence of IT professionals and a continuous learning pathway for IT professionals to enhance their capabilities and advance in their career development".

Evidently, CPIT Credentials is well appreciated for its effort to help improve the quality and standard of IT professionals, thus foster the overall development of the industry.

### **About Certified Professional of IT (CPIT) Credentials**

Led by Hong Kong Computer Society, The Hong Kong Institute for IT Professional Certification (HKITPC) was established with the assistance of the government in 2007. CPIT is a set of qualifications set up to give recognition to IT professionals, making the IT industry more competitive and boosting further development. Certified Professional of IT Credentials (CPIT), the only recognition for IT professionals that is approved in Hong Kong and aligned with the Qualifications Framework of the Hong Kong Education Bureau, is the professional certifications launched by HKITPC.

The 3 assessment-based titles were launched between 2006 and 2007 while the 3 examination-based titles were launched from 2008 to 2010. The 2 recognized-based titles are being launched this year. The development of the project was sponsored by the Office of the Government Chief Information Officer (OGCIO), indicating support from the government to the Hong Kong Certification system.

The Hong Kong Institute for IT Professional Certification is a non-profit organization established in 2007 under the assistance of the government.
