Hong Kong Institute for IT Professional Certification Signs Agreement with The Hong Kong Polytechnic University

Exemption of exam for 2 CPIT titles for eligible EIS graduates

With the objective to encourage IT professionals to enter into CPIT program

23 September 2014-Hong Kong - The Hong Kong Institution for IT Professional Certification (HKITPC) has signed an Agreement with The Hong Kong Polytechnic University (PolyU) today. Eligible PolyU graduates from the Department of Computing will be offered an exemption from the required examination and fee for Certified Professional of IT (CPIT) Credentials.

CPIT is a certification system that assesses and certifies IT professionals based on knowledge, skills, ability, and proven work experience. Among the 8 existing titles in the certification, 3 of them are examination-based, including Associate Project Manager (APM), Information Security Officer (InfoSec) and Business Analyst (BA). To achieve the certification, an examination fee will also be charged.

In order to encourage IT professionals to enter into CPIT program, HKITPC and PolyU have reached an Agreement today to establish an Exemption Arrangement to recognize eligible PolyU graduates as Exempted Graduates, offering them an exemption of examination and examination fee for CPIT (APM) and CPIT (BA).

The Agreement signing ceremony was held at the PolyU campus today, co-hosted by Ir. Stephen Lau, J.P., Chairperson & Director in charge of The Hong Kong Institute for IT Professional Certification Limited, and Prof. Jiannong Cao, Chair Professor and Head of the Department of Computing of The Hong Kong Polytechnic University. According to the agreement, Exempted Graduates of Enterprise Information System (EIS) students from the Department of Computing of PolyU will be acknowledged to apply for CPIT credentials of the "CPIT (APM)" or the "CPIT (BA)" if they have fulfilled two requirements: Firstly, the candidate must fulfill the graduation requirement of the EIS curriculum, by completing and passing a set of required courses to achieve the competency requirements of the certificate concerned; secondly, the candidate must acquire at least two years' full-time experience in IT related jobs after graduation. However, when the EIS graduates fulfill the first requirement, they can already apply for CPIT credentials of the "CPIT (APM Candidate)" and the "CPIT (BA

Candidate)".

Prof. Cao expected that the set-up of this collaboration can motivate graduates to enter into the CPIT Program, pursue self-excellence, and sustain their competitive edge in the field. Ir. Stephen Lau pointed out that, "CPIT Credentials have been well-recognized as a constructive force for the IT industry," and he hopes that this agreement will help nurture more IT elites, contributing to the overall development of the field.

A CPIT Forum, 'CIO Forum – 360 Value Creation through IT Professional Certification,' organized by Hong Kong Computer Society, and co-organised by HKITPC and Cyberport, will be held at Cyberport on 25 Nov (Tue). approved in Hong Kong and aligned with the Qualifications Framework of the Hong Kong Education Bureau, is the professional certification launched by HKITPC.

The 3 assessment-based titles were launched between 2006 and 2007 while the 3 examination-based titles were launched from 2008 to 2010. The 2 recognized-based titles are being launched this year. The development of the project is sponsored by the Office of the Government Chief Information Officer (OGCIO), indicating support from the government to the Hong Kong Certification system.
